

MEMORANDUM OF UNDERSTANDING (MOU)

AGREEMENT for implementation of Academic Program or Add-on Program as per the Curriculum/Courses of the Institute/University

LI-MAT Soft Solutions Pvt. Ltd. having its office at R-22, 3 Cross, above Canara Bank, Electronic City Prathik Tech Park, Electronic City Phase 1, Bengaluru, Karnataka 560100 specializes in conducting training on various Programming Languages as per the course/curriculum of the Institute & university. Here in after referred to as "Academic Partner".

And

The Mou is entered into on the **7th day of October, 2023** by and between **KIPM-College of Management**, Gorakhpur U.P. (herein after called KIPM-CM) situated at Gorakhpur (U.P) an institute affiliated to Dr. A. P. J. Abdul Kalam Technical University, Lucknow, U.P.

The aforesaid organizations are hereinafter referred to individually as Institution/ University and collectively as institution.

1. Objectives of the MoU

Now therefore both the parties hereby agree as follows:

- a) **ACADEMIC PARTNER** will provide an assist for the installation of licensed software according to Annexure-1 in the INSTITUTE Computer lab.
- b) **ACADEMIC PARTNER** will conduct various Programming Languages courses for students of

- INSTITUTE** at the Institute's premise by providing specialized Faculty as per the course/curriculum of the Institute which is essential for the award of educational qualification to the trainee students.
- c) **ACADEMIC PARTNER** will also provide a training manual & literature related to the training to the students/institute.
 - d) **Both parties** will work towards creating better awareness of programming languages/Application Software for the completion of the course/curriculum of the Institute and better employability of participants.
 - e) **ACADEMIC PARTNER** in consultation with **INSTITUTE** will create and refine courses/curriculum.
 - f) Course Name/duration/curriculum/special terms will be as per the discussion with the respective departments. After finalization would be added as an annexure to the MOU.
 - g) Course fee & reimbursement will be as per the mutual decision between both the **ACADEMIC PARTNER** & the **INSTITUTE**.

Responsibility of ACADEMIC Partner

- a) **ACADEMIC Partner** will Provide Trainer with requisite knowledge and experience in teaching the programming languages/Application Software.
- b) **ACADEMIC Partner** will ensure substitute faculty of similar specialization, as per requirement.
- c) **ACADEMIC Partner** will conduct tests/examinations for the students as part of the training program.
- d) **ACADEMIC Partner** will conduct faculty development programs for awareness of the latest software used for the faculties of the **INSTITUTE**.
- e) **ACADEMIC PARTNER** will maintain a record of attendance and submit the complete training report for each student at the end of the program.

Responsibility of the Institute

- a) Provide requisite infrastructure to conduct courses, including but not limited to, classrooms, Computer Hardware, Computer Projector, black/ whiteboard, power, power backup, Other utilities, etc.
- b) **INSTITUTE** will register students in the Course with adequate information on all relevant streams.
- c) **INSTITUTE** will provide lodging to the trainer for the duration of the training.
- d) **INSTITUTE** will be responsible for payment of training fees when conducted to the **ACADEMIC PARTNER**.
- e) Reimburse training fee & taxes as/applicable to **ACADEMIC PARTNER** as per agreed terms.
- f) Ensure that all the participating students attend Course Classes as per the schedule and that all required infrastructure is made available for uninterrupted classes.
- g) Institute would ensure that all students are regular in attendance and irregular students need to drop out/rescheduled in the next batch without any reimbursement.

Duration of This Agreement

- The duration of this Agreement shall be for a period of 1 year from the date of signing.

Termination

- This agreement shall take effect immediately on the execution of these presents. This agreement can be terminated by any party by a written letter giving one (1) month notice period.
- Upon expiry of the notice period this agreement will be terminated & both parties will settle their accounts within one month of termination of this agreement.
- Any notice request or other communication required or permitted to be given or made under this agreement to **INSTITUTE** or **ACADEMIC PARTNER** shall be in writing. Such notice or request shall have been given or made when it shall have been delivered by handmaid mail with a copy by facsimile, to the party to which it is addressed at such party's address specified below or at such other address as such party shall have designed by notice to the party for giving such notice or making such request.
- Except as otherwise specifically provided here in this agreement, shall bind and inure other benefit of each party's successors & permitted assigns.
- The parties here acting themselves or through representatives duly authorized, have caused this agreement to be signed in their respective names as of the day & year written above.

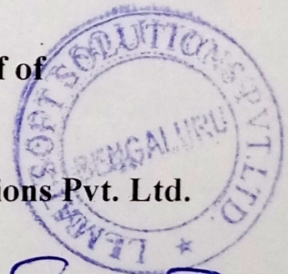
