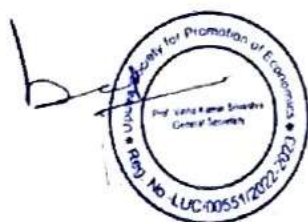
Memorandum of Understanding

This Memorandum of Understanding (MOU) will be for **Five (05) years**, unless and until there is any valid and legitimate reason to end and may be renewed for a further period of one year or such time period as agreed by both the parties in writing.

On the behalf of the College, **Er.R.D. Singh, Chairman, KIPM College of Management, GIDA, Gorakhpur (UP)** and **Prof. Vinod Kumar Srivastava, General Secretary, Uttar Pradesh-Uttarakhand Economic Association (UPUEA)** will be the point of contact for further correspondence and coordination.

The following areas have been worked out for the collaboration;

1. For the dissemination of knowledge and encouraging younger research scholars and faculty member International/ National Conferences and Seminars may be organised.
2. For specific training and hand on new methods and techniques in the research and skill development workshops may be organised.
3. A series of lectures may be organised to teach and explain specific topics out of prescribed postgraduate syllabus to the students of the College/Association and other academically interested persons.
4. A series of lectures/ courses may be organised for the skill development in specifics areas for the Undergraduate students of the College /Association and other academically interested persons.
5. To train newly admitted Ph.D. students in the research methodology short term courses may be arranged.
6. A series of lectures may be organised to teach and explain integrated subjects/ multidisciplinary subjects.
7. Outreach program comprises of lectures and demonstrations may be organised in the rural areas of the College catchment to bring deprived youth of the rural background at par with urban youth.
8. To create interest and awareness about the Socio-economic development of Uttar Pradesh and Uttarakhand region, field trips may be organised for the students of the College and Association.
9. The agreement reflected by the provision of the MoU is non-exclusive in nature and both the parties can enter into co-operative arrangement with other parties to suit their organizational need.
10. Publication programs may be undertaken for the dissemination of the knowledge and to encourage young researchers to write and publish good

2. The College and Association cannot charge any tuition fee form the enrolled students; it will be open and up to the College /Association to charge any reasonable fee, tuition fee, & Contribution amount etc. to meet out expenses form outside participants, if any.
